Important Notice about CareFirst Groups

CareFirst BlueCross BlueShield recently experienced a cyberattack, resulting in limited and unauthorized access to the organization's database. To protect the privacy and security of its members, CareFirst has implemented new, enhanced online security measures for all users of the CareFirst member portal.

As a result of these protective measures, Choice Strategies will no longer be able to provide our Substantiation Service to CareFirst members. We will continue to automatically substantiate transactions that can be verified by our systems. However, certain claims and card transactions submitted to Choice Strategies will now need to be supported with documentation to verify that they are eligible expenses under an employer's plan. Employees can access information regarding this process on the Choice Strategies website.



PCORI Fee Calculations Coming Soon!

Effective July 13, 2015, Choice Strategies can only make provider payments when members submit their claims online. Members can easily create an online account by going to www.choice-strategies.com/member-faqs. In the left column, they should click on the "create an account" button to get started.

If a member files a paper claim and requests a payment be made directly to a provider, Choice Strategies can only reimburse the member, not the doctor's office or hospital for example. In this instance, the responsibility of paying the
