



The **Health Insurance Marketplace** will be undergoing maintenance from 3:00 AM ET until 4:00 AM ET on Thursday, 12/03/2015. During this time, access to the **Marketplace Application and Enrollment Tools** will be unavailable.

The **Social Security Administration (SSA)** will be switching to their secondary site from 1:00 AM ET until 5:00 AM ET on Thursday, 12/03/2015. During this time, SSA Title II Monthly/Annual and Quarters of Coverage verification services accessed via the Federal Data Services Hub will be unavailable.

As a result, requests for these components of the SSA service will not receive a successful response. Therefore, a consumer's application within a State's Marketplace may be impacted. All other SSA verification services via the Federal Data Services Hub will continue to be available. Consumer application submission through the Federally Facilitated Marketplace is not impacted by the site switchover.
