What is the overall deductible?	\$1,500.00 /Individual or \$3,000.00 /Family for out-of-network providers.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this plan begins to pay. Are there services covered before you meet your deductible?	Yes. Preventive care is covered before you meet your deductible. Does this plan provide Minimum Essential Coverage? Yes
