Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. Are there services covered before you meet your deductible?	Yes. Preventive care is covered before you meet your deductible .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply.
