What is the overall deductible ?	\$2,000.00 / Individual or \$4,000.00 / Family for in-network providers and \$4,000.00 / Individual or \$8,000.00 / Family for out-of-network providers .	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible .
Are there services covered before you meet your deductible ?	Yes. Preventive care is covered before you meet your deductible .
