#### AmeriHealth NJ Prescription Claims Transition to RxClaim

From July through September, AmeriHealth New Jersey will be transitioning prescription claims processing platforms from Argus to RxClaim. On and Off exchange individuals and small groups will be transitioned beginning on July 1, 2016. Large groups (51+), self funded groups and Medigap plans will begin transitioning on September 1, 2016. This transition will be seamless for our members. ### **2015 Electronic Information Reporting Due to the IRS by June 30th**

The Affordable Care Act (ACA) requires "large employers" to report to the Internal Revenue Service (IRS) information regarding all fulltime employees to whom they offered health coverage, called Large Employer Reporting. Insurers and self insured health plans must also submit reports to the IRS regarding individuals who were enrolled in their health coverage at any point during 2015. For electronic filings, both sets of reports are due by June 30 and relate to coverage in 2015. Click [here](#) to read more.
