AmeriHealth NJ Offers a Transition Period for 51-100 Customers

AmeriHealth has made available some strategies to help our customers maintain their large group coverage for as long as possible. If customers are interested in the opportunity to extend their large group coverage, they may need to take action now.

2015 Early Renew Option

As a result of the 2016 transitional relief only remaining available until October 2016, AmeriHealth New Jersey will offer some large groups the opportunity to request an early October 1, 2015 renewal. This will delay the customer's mandatory transition into a small group metallic plan until October 1, 2017.

To be eligible for this early renewal option groups must:

- have an anniversary date between November 2015 and March 2016
- have 51-100 eligible employees (AHNJ Large Group Certification required)
- request an early October 1, 2015 renewal quote by August 15, 2015
- respond to the October 1, 2015 renewal quote by September 15, 2015

2016 Transitional Relief

Upon renewal beginning January 2016, through October 2016, AmeriHealth New Jersey customers with 51-100 eligible employees have the opportunity to delay their transition to a metallic plan by remaining in their existing product type. Customers choosing transitional relief will have the opportunity during their January through October 2016 renewal to make changes within their product type, defined as: HMO, POS, IC POS, EPO, or PPO. Customers may also make cost-share changes as long as they stay within the same product type.

Cigna ~ Second 40% Excise Tax ("Cadillac Tax") Notice Issued

On July 30, the Department of the Treasury and the Internal Revenue Service (IRS) issued a second notice regarding the 40% Excise Tax a.k.a. the Cadillac Tax. The notice provides information on possible approaches that are being considered for administering the Cadillac Tax and continues the process of gathering input that will be used to develop regulations.

IRS ~ Overview of the Employer Shared Responsibility Provisions

The Affordable Care Act contains specific responsibilities for employers. The size and structure of your workforce - small, large, or part of a group - helps determine what applies to you. Employers with 50 or more fulltime equivalent employees will need to file an <u>annual information return</u> reporting whether and what health insurance they offered employees. In addition, they are subject to the <u>Employer Shared Responsibility provisions</u>. All employers that are applicable large employers are subject to the Employer Shared Responsibility provisions, including federal, state, local, and Indian tribal government employers.

IRS ~ Find Out if Your Health Coverage is Qualifying Coverage under the Health Care Law

The Affordable Care Act requires you and each member of your family to have qualifying health care coverage, qualify for an exemption from the responsibility to have minimum essential coverage, or make an individual shared responsibility payment when you file your federal income tax return. For purposes of ACA, qualifying health care coverage is also known as minimum essential coverage.
