CARRIER UPDATES

CIGNA - Cadillac Tax and Health Insurer Tax Delayed

On Jan. 22, President Trump signed into law a short-term spending bill (called a Continuing Resolution or "CR") to reopen and fund the federal government for three weeks (through Feb. 8, 2018) after it was passed by both chambers of Congress earlier in the day. Attached to the bill are delays or suspensions of three taxes under the Affordable Care Act (ACA) and a six-year extension of the Children's Health Insurance Program (CHIP). The 40% Excise Tax or "Cadillac Tax" implementation is delayed two additional years, with a new effective date of Jan. 1, 2022. The Health Insurance Industry Fee is suspended for one year (2019) and the Medical Device Tax is suspended for two years (2018-2019)
