





## New Agent and Broker Marketplace Registration Tracker Now Live!




The Centers for Medicare & Medicaid Services (CMS) just rolled out a [brand-new tool](#) that allows you to look up your Marketplace registration status using your National Producer Number (NPN) and ZIP code.

The tool shows you a summary of your Marketplace registration status and details:
