#### Horizon BCBS Special Enrollment Periods

Once the annual Open Enrollment Period is closed, an eligible individual can only enroll in an individual health insurance plan if he or she qualifies for a Special Enrollment Period (SEP). Horizon BCBS has come out with a list of what the triggering events are the documentation required to prove eligibility. Alternate documentation may be accepted if it provides proof of the triggering event and the date. [Read More](#).

### **Keep Your Health Insurance Documents with Your Tax Records**

This year marks the first time that you may receive information forms about health insurance coverage. You do not need to send these forms to IRS as proof of your health coverage. However, you should keep any documentation with your other tax records. This includes records of your family's employer provided coverage, premiums paid, and type of coverage. You should keep these - as you do other tax records - generally for three years after you file your tax return. [Read More.](#)

### **OCA Benefits Updates (Run out Period, Holiday Closing)**

For any HRA/FSA plan that ended on 12/31/15, the 2015 claim submission deadline may soon be approaching! Employees may be required to submit any 2015 claim by midnight of March 30, 2016 to be eligible to receive reimbursements for any 2015 date of service. Please note that since it was a leap year the 90 day run out period is one day earlier (March 30th). [Read More.](#)
