CARRIER UPDATES

Horizon BCBS - Reporting Member's Coverage Still Required by the ACA

Under the Affordable Care Act's (ACA) Insurance Coverage Reporting requirement, Horizon Blue Cross Blue Shield of New Jersey must provide information to the Internal Revenue Service (IRS) about its fully-insured members' health insurance coverage using each member's Social Security Number (SSN) and the SSNs of any individuals covered under their policy. For the third consecutive year, Horizon BCBSNJ will collect and submit this information to the IRS on behalf of its fully-insured members as proof that they had minimum essential health insurance coverage in 2017. Additionally, Horizon BCBSNJ is required to send the 1095-B Form to fullyinsured members by January 31, 2018 and electronically to the IRS by March 31, 2018 as proof of the coverage.

CMS - Announces New Medicaid Policy to Combat Opioid Crisis

Today, the Centers for Medicare & Medicaid Services (CMS) announced a new policy to allow states to design demonstration projects that increase access to treatment for opioid use disorder (OUD) and other substance use disorders (SUD). CMS's new demonstration policy responds to the President's directive and provides states with greater flexibility to design programs that improve access to high quality, clinically appropriate treatment. In addition, CMS is announcing the immediate approval of both New Jersey and Utah's demonstration waivers under the new policy.

CIGNA - Wellness Compliance Reminder

Under the Affordable Care Act (ACA), Americans with Disabilities Act (ADA) and Genetic Information Nondiscrimination Act (GINA), employers need to comply with several rules regarding wellness programs and incentives. These rules focus on the value of incentives, reasonable alternatives, required notices, and frequency of incentive opportunities. The Department of Labor (DOL) has increased enforcement and regulatory scrutiny around these rules, particularly related to tobacco cessation programs.
