HEADLINE

New Jersey Legislators Pass Measure to Create State Based Individual Mandate

A state Senate panel passed legislation that institutes a state based individual mandate requiring citizens of the state to either purchase insurance or pay a fee.

If Governor Phil Murphy signs the bill, New Jersey would become the first state to issue an individual mandate after the Tax Cuts and Jobs Act of 2017 removed the financial penalty from the federal individual mandate.

Healthcare.gov - April 11th Edition News for Agents and Brokers

When helping clients enroll through a special enrollment period (SEP), be sure your National Producer Number (NPN) is recorded on the eligibility portion of your client's Marketplace application. Your NPN must be recorded so the qualified health plan (QHP) issuer can identify you as the assisting agent or broker. Even if your client's QHP issuer doesn't compensate agents and brokers for SEP enrollments, your NPN will persist on the client's application and be pre-populated when your client re-enrolls during the next Open Enrollment period (whether actively or passively). The issuer may then pay commissions for the coverage renewal, in accordance with applicable laws and requirements.
