#### AmeriHealth - Out of Network Reimbursement Update for SEH

AmeriHealth New Jersey will be updating its out of network (OON) reimbursement methodology for SEH products and plans with an OON benefit, in a phased approach. The first phase is effective for SEH new business and upon renewal for current SEH customers, January 1, 2017, through April 30, 2017. The second phase will be effective for SEH new business and upon renewal for current SEH customers, May 1, 2017, through the end of the year.

AmeriHealth will be communicating this change to current SEH customers through their Renewal package cover letter, sent 60 days prior to their renewal date. A separate letter will be sent to notify any SEH customers who have already received their Renewal package, or completed their 2017 renewal.

#### Healthcare.gov - Ensure You Get Credit for Your Marketplace Enrollments!

When assisting clients enrolling in coverage through HealthCare.gov and the Marketplace (or SidebySide) Pathway, make sure to include your National Producer Number (NPN) on both the application AND on Plan Compare. Your NPN must be listed correctly for you to receive compensation for enrollment transactions.
