CMS is launching enhancements to the Marketplace Learning Management System (MLMS) for plan year 2018. In addition to a more modern, improved look and feel, you can use new features, such as:

- Improvements to how the curriculum is displayed to make it easier for you to find the appropriate courses

### AmeriHealth - Medicare exclusion mailing for group members to begin

Starting the week of July 24, AmeriHealth New Jersey will start mailing letters with an FAQ on a monthly basis to all fully insured and self-funded group members who are, or will soon be, eligible for Medicare and whose group benefit includes the Medicare Exclusion. Eligible members will be encouraged to enroll in Medicare Parts A and B by a specified date, in order for them to maximize their health plan benefits and minimize expenses.

### OCA - Contribution Billing: New Process Effective 8/1

As a reminder, effective August 1, 2017, OCA will automatically post the employee contributions for FSA and Commuter groups. OCA will continue to provide the contribution reports on a monthly basis. Employers will ONLY have to notify OCA if

there are any changes to those contributions. This will result in a more efficient and timely process for employers and their employees. OCA will still require employers to confirm the 1st payroll report for each plan year.
