### HEADLINE

#### **LabCorp to Become AmeriHealth's Exclusive Outpatient Lab**

Effective May 1, 2018, LabCorp will become AmeriHealth's exclusive outpatient lab. The following lab vendors will no longer be in-network: Quest Diagnostics effective 10/1/17, BioReference effective 3/1/18, and Health Network effective 5/1/18. When the Quest, BioReference, and Health Network contracts terminate, AmeriHealth New Jersey will generate new ID cards for members with a primary care provider (PCP) capitated to a terminating lab.

This July, prior to the Quest contract termination, PCPs will be given the opportunity to select another participating capitated outpatient lab. As a result, ID cards will be generated in September for large and small group members with renewal dates from February - September, that have a PCP still capitated to Quest.

ID cards will be generated for members that have a PCP capitated to BioReference and Health Network in 2018 prior to the respective contract termination.

All customers and subscribers will be notified that LabCorp will be our exclusive national outpatient laboratory provider effective May 1, 2018. Customer and subscriber notifications will be sent at the end of August prior to the Quest termination, and the generation of replacement ID cards.

## **Cigna - ACA Repeal and Replace Efforts Continue in the Senate**

On June 22, the U.S. Senate released a discussion draft of the Better Care Reconciliation Act (BCRA) to repeal parts of the Affordable Care Act (ACA). The BCRA is the Senate Republicans' alternative to the American Health Care Act (AHCA) passed in the House in early May. There is not enough support among Senate Republicans to consider the bill this month, so Senate Republican leaders will attempt to schedule a vote on the BCRA following the July 4th recess provided the bill has garnered sufficient Republican backing.

## **Healthcare.Gov - Print Your Registration Completion Certificate(s)**

The MLMS will be closed starting July 21st at 12:01 pm until training for plan year 2018 goes live in August. Before this "go dark period" begins you should confirm your MLMS profile is up-to-date and print your registration completion certificates. Certificates reflecting that you've completed plan year 2017 registration and training WILL NOT be available when the MLMS closes and WILL NOT be available when the system goes live in August for plan year 2018 registration and training.
