### HEADLINE

#### CMS Replacing Social Security Number with Random Number on Medicare ID Cards

Fraud and identity theft are two major issues that impact the insurance industry. In an effort to prevent these issues from occurring as well as to protect essential program funding and the private healthcare and financial information of Medicare beneficiaries, CMS will be removing Social Security numbers from all Medicare cards.

CMS will issue new Medicare cards with a new unique, randomly-assigned number called a Medicare Beneficiary Identifier (MBI) to replace the existing Social Security-based Health Insurance Claim Number (HICN) both on the cards and in various CMS systems used today now. CMS will start mailing new cards to people with Medicare benefits in April 2018. All Medicare cards will be replaced by April 2019.

#### CMS Began Sending Medicare Periodic Data Matching Notices

These notices are being sent to all consumers dually enrolled in an Exchange plan and Medicare, and for the first time, will be sent to all consumers eligible for Medicare, regardless of their age. Consumers will receive a paper notice requesting they return to the Exchange and follow the listed instructions regarding their dual enrollment status, to end their Exchange coverage.

#### Cigna - 2017 Comparative Effectiveness Research Fee Due July 31

The fee is based on the average covered lives for the applicable 12-month policy or plan year. It is paid using IRS Form 720 by July 31 each year for the plan year that ended in the preceding calendar year.

### **Oxford/UHC - Action Required for New York Small Groups**

As a reminder, New York small groups currently offering only an Oxford Health Plans (NY), Inc. (OHP) HMO plan with a coverage end date of July 1, 2017 need to purchase a new Oxford Health Insurance, Inc. (OHI) policy before their current OHP plan ends. These groups did not receive a renewal package from the carrier and need to apply as a new group.
