If approved, the proposed service area will include the following counties:



CARRIER UPDATES

NAHU - CMS Launches SEP Verification Program

On June 23, 2017 the Centers for Medicare and Medicaid Services (CMS) announced the launch of the special enrollment period (SEP) pre-enrollment verification program that will be conducting pre-enrollment verification of eligibility of applicants applying for exchange coverage through applicable SEPs.

Beginning on June 23, 2017, consumers newly enrolling in Marketplace coverage through a SEP due to a move or loss of qualifying coverage (also called minimum essential coverage) will be required to submit documents to confirm their SEP eligibility before they can begin using their coverage. After they submit their application, they'll get an Eligibility Determination Notice (eligibility notice) with a list of documents they can send to provide this confirmation.

CMS also released an [updated chart](#) of the SEPs available to consumers. The chart will be posted to RegTap.

OCA - Contribution Billing

Effective August 1, 2017, OCA will automatically post employee contributions. OCA will continue to provide the contribution reports on a monthly basis. Employers will now ONLY notify OCA if there are any changes to those contributions. This will result in a more efficient and timely process for employers and their employees. **For employers with FSAs, the 1st payroll report for each plan year will still be required to be confirmed.**
