#### Two Important Changes Effective October 1, 2017

Beginning October 1, 2017, CarePoint Health Hospitals - Christ Hospital, Bayonne Medical Center and Hoboken University Medical Center - will be participating in the Horizon Hospital Network. Horizon BCBSNJ has reached a new agreement with CarePoint Health Hospitals that will add CarePoint Health Hospitals back to the Horizon Hospital Network. Quest DiagnosticsTM (Quest) will terminate as an AmeriHealth New Jersey participating lab effective October 1, 2017, and will be out-of-network at that time. As a result of the Quest termination, all customers and subscribers will be notified of this lab network update, and ID cards will be reissued to affected members in the coming weeks.

AmeriHealth New Jersey members can continue to seek in-network lab services from the following remaining outpatient labs until their participation with AmeriHealth New Jersey ends:

- BioReference Laboratories (BioReference) will terminate effective March 1, 2018, and will be an out-of-network provider at that time.
- Health Network Laboratories® (Health Network) will terminate effective May 1, 2018, and will be an out-of-network provider at that time.
