Open Enrollment for the individual market starts November 1st and last until December 15th.

Brokers must be re-contracted with the carriers to sell individual insurance - you must take action even if you are only doing off-exchange business and even if you did it last year!

# **Horizon BCBS - Changes to Small Employer Health Plans**

Horizon Blue Cross Blue Shield of New Jersey has updated its small employer health plan portfolio for 2018. The charts in this Brief Notes provide information about the changes for 2018. These changes will become effective when a small employer customer renews into one of the Horizon BCBSNJ health plans listed in this Brief Notes. In addition to the health plan changes, small employer customers that want to purchase or renew a health plan on the Small Business Health Options Program (SHOP) for 2018

must do so through a broker. Small employer customers that purchased on SHOP in 2017 will receive a letter advising of this change.

This year's Open Enrollment begins November 1, 2017 and runs through December 15, 2017. Remember that you must complete plan year 2018 Marketplace registration and training prior to assisting consumers.

#### **CIGNA - 2019 Notice of Benefit and Payment Parameters**

On Oct. 27, 2017, the Department of Health and Human Services (HHS) issued proposed regulations related to a wide range of Affordable Care Act (ACA) benefit provisions. In addition to the annual benefit provision updates, this proposed rule would increase state flexibility for Essential Health Benefits (EHBs) and reduce some regulatory requirements in the individual and small group markets. It also includes an increase to the consumer out-of-pocket maximums.
