### HEADLINE

#### **Members Health Plan NJ: Sponsoring Organization Requirements!**

As a reminder, Effective 1/1/2020, all employer groups will be required to be a member of one of their sponsoring organizations. It is also important to remind your employers that payments to below associations **MUST** be made by the employer, not a broker or other third party. If employer is unable to make the payment, they will not be eligible for the Health Plan.

Physicians and Medical Practices must provide documentation that they are members of one of the following organizations:

- Medical Society of New Jersey
- CentraState Medical Center
- IPA of North Jersey
- Trinitas Hospital Medical Staff
- Mountainside IPA
- Northwest Physician Organization, Inc.

- The Medical & Dental Staff of Hackensack Meridian Health
