Horizon BCBSNJ - Determining Group Size

Effective for coverage beginning January 1, 2017, the New Jersey Small Employer Health Coverage Program (SEH Program) has aligned its definition of Small Employer for health insurance coverage purposes with the federal definition. This means that the methodology used to determine the small employer's group size will now look only to the total number of full-time and full-time equivalent employees (FTEs).

A few key things to consider:

1. A Small Employer is one that employed an average of at least one but not more than 50 employees on business days during the prior calendar year and at least one employee on the first day of the Plan Year.
2. A Large Employer is one that employed an average of at least 51 employees on business days during the prior calendar year and at least one employee on the first day of the Plan Year.
3. In the case of an employer that did not exist in the prior calendar year, the determination of whether an employer is a Small or Large Employer is based on the average number of employees that is reasonably expected will be employed in the current calendar year.
4. The following are not considered employees for Small Employer coverage under New Jersey's Small Employer Health Coverage Program (SEH) rules or for Large Employer coverage:
 - An individual and his or her legal spouse when the business is owned by the individual or by the individual and his or her legal spouse
 - Partners in a partnership
 - Sole proprietors
 - A 2-percent S corporation shareholder
 - Independent contractors
 - Leased employees
 - Retired enrollees
 - COBRA continuees

Aetna Senior Supplemental - Want to Earn Extra Cash This Winter?

Between January 18 - March 31, 2017, you can receive a bonus payout of \$200 per underwritten policy and \$50 per open enrollment policy issued when you submit qualifying applications of Medicare Supplement in some states. There's no limit to the amount of extra cash you can earn! To receive the bonus payout, you must have a minimum of 5 policies issued in January or 10 policies per month, February and March.
