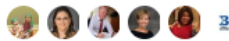

Starting on August 18, 2017, members who have pharmacy coverage through Horizon and use the PrimeMail home delivery service will have their prescriptions filled by Walgreens Mail Service pharmacy. This transition period may last through the end of the year. PrimeMail by Walgreens Mail Service will provide members with the same convenient service and access to maintenance medications. Members should use the same phone number that is printed on their prescription label and found on the back of their Horizon BCBSNJ member ID card for questions about prescriptions or to request a refill.

CMS - Webinar Overview: Special Enrollment Period Pre-Enrollment Verification (SEPV)

Beginning in the summer 2017, new applicants (those applicants who are not already enrolled in Marketplace coverage) who attest to certain types of SEP qualifying events will be subject to the SEPV process of pre-enrollment verification. Eligible consumers must submit documents that confirm their SEP eligibility before they can enroll and start using their Marketplace coverage. SEPV is being implemented in two phases: Phase 1 began on June 23, 2017 and Phase 2 starts on August 23, 2017.
