Health Republic - Changes to Specialty Drug Coverage

Health Republic's formulary incorrectly classified all specialty drugs as Tier 4 prescription medications, which means they were subject to the highest level of cost sharing. New Jersey regulations require that their formulary's most preferred tier (the tier with the lowest cost-sharing) includes more than one drug used to treat each covered disease state where more than one drug is available.
