Earlier this month the IRS issued the final regulation on the new HRAs. This guidance allows for two new HRA arrangements starting 2020- the individual Coverage HRA (ICHRA), and the Excepted Benefit HRA (EBHRA). The webinar will be held, **July 11th from 11:00 AM to 12:00 PM**.

# **Cigna Senior Products: New Signature Date Changes!**

Beginning July 1, 2019 Cigna will be implementing a policy change on the timing between the signature date and effective date of an application. They currently allow policy quoting 180-days prior to the effective date. The new change will now limit quoting to 90-days between the signature date of the application to the effective date.

### HealthCare.gov: Marketplace Weekly Digest June 24-28!

As of June 14, agents and brokers using a Direct Enrollment (DE) Pathway must confirm their clients have given them consent to work with them for purposes of applying for and enrolling in a Marketplace qualified health plan (QHP) with or without financial assistance, Medicaid, or CHIP through the Marketplace. To confirm consent, agents and brokers must click the **Confirmation** checkbox on a DE Pathway search page.
