### HEADLINE

#### **Horizon Brief Notes: Creditable Coverage Notice Reminder!**

Health plan sponsors (employer groups) that offer prescription drug coverage to Medicare-eligible employees and their dependents are required to notify those employees and dependents whether their coverage is creditable or non-creditable. Notifications must be sent before 2020 Medicare Annual Election Period, which begins on October 15, 2019. This requirement is part of the Medicare Prescription Drug, Improvement, and Modernization Act (MMA).

As defined by the Centers for Medicare & Medicaid Services (CMS), prescription drug coverage is creditable if the actuarial value of the coverage is equivalent to, or better than, the actuarial value of standard Medicare Part D prescription drug coverage. A non-creditable prescription drug plan has an actuarial value that is less than the standard Medicare Part D coverage.
