Reduction in HSA Contribution for 2018

As a result of the Tax Cuts and Jobs Act, the IRS has recalculated the limits for HSA contributions and a few other employee benefit contribution limits.

Internal Revenue Bulletin No. 2018-10, released March 5, states that for HSAs, the annual tax-deductible contribution limit for tax year 2018 will stay at \$3,450 for singles, but the family contribution level has been lowered to \$6,850 from \$6,900.

Health care flexible spending accounts (FSAs), transit and other benefit limits now linked to the chained CPI were not affected for 2018.
