Revision to Oscar's Q1 2019 New Jersey Small Group New Business Bonus Program!

Oscar's current bonus program has been modified due to NJ regulations. The revisions, which can be viewed by [clicking here](#), indicate that the bonus is \$50 per life (the higher of the two values in the previously issued documents), payable subject to the conditions laid out in page 2 of the revised document.

UnitedHealthcare Oxford: IRS 1095-B Form

UnitedHealthcare has received inquiries from some Oxford subscribers about their receipt of multiple IRS 1095-B forms. This form provides information needed for covered individuals to report on their income tax return; specifically, proof of qualifying health coverage (minimum essential coverage) for some or all months during the year. Similar information must also be filed with the IRS on the IRS 1094-B form.
