APEHP: July New Business and Renewal Announcement!

New business rates are now available and July renewals are deferred until October 1st. In order to make this transition as seamless as possible for you and your clients, APEHP will be deferring the July renewal to October 1, 2019.

New Business will be on the new Aetna Platform. There will be 14 benefit plans offered for 7/1, 8/1 and 9/1 (Plan B, F, J, L, M, N, O, P, R, S, V, X, Y and Z) along with the current 6 Prescription Plans and 4 Dental Plans. OCA will continue to be the HRA/FSA Vendor.

Lastly, clients under the Aetna Platform will be introduced to a new name, Members Health Plan NJ.
