Customers who are qualified to receive premium rebates for the 2019 MLR Payout Year are expected to receive their checks by Sept. 30 deadline.

For benefit plan year 2018 (2019 MLR Payout Year), UnitedHealthcare's results show 49 aggregation sets - 45 group and 4 individual-qualified to receive premium rebates totaling \$169,633,214.
