### ***Updated Link: 2020 Horizon Individual Broker Registration!***

Below is the 2020 Horizon Individual Broker link and unique PIN code. Please remember, an agent/broker can only be linked to one Master Broker for both their Horizon BCBSNJ Individual ON and OFF Marketplace and SHOP business throughout the entire 2020 calendar year.

An agent/broker will be allowed to move their business to a different Master Broker one time annually (October 1st thru December 31st) after completing their 2020 registration prior to the start of the new calendar year. Agents without a registered NPN number on file will not receive compensation from Horizon BCBSNJ until their registration is complete.

All agents will go to <https://miramar-agent.com> and log in with their username/password from last year. Returning agents who have forgotten their password can use the "Forgot your password" link on the home page. Agents will need to enter their username and
