In February 2014, the state released [Advisory Bulletin 14-SEH-01](#) which created an opportunity for carriers to seek DOBI approval to make changes to the participation calculation with respect to individuals receiving Advanced Premium Tax Credits (APTC).

Health Republic and Horizon BCBS have come out with updated participation guidelines. In each case, there are specific conditions that have to be met to take advantage of the alternate calculation.
