New Jersey Transitional Relief Coverage Extended

Federal and New Jersey regulators recently announced that Transitional Relief coverage will be extended. The extension applies to groups with policies that renew on or before Oct. 1, 2018 provided that all such policies end by Dec. 31, 2018.

We will be allowing Oxford New Jersey small groups that were previously enrolled in their 2013 coverage through a Transitional Relief policy **and have not yet passed their 2017 renewal date** to renew into their Transitional Relief plan.

If your clients have already been mailed a 2017 renewal offer:

Renewal offers have been mailed to Oxford New Jersey small groups scheduled to renew their 2017 coverage between April 1, 2017 and July 1, 2017. These letters state that their Transitional Relief policy will not be available for renewal in 2017.

These groups will receive a **follow-up letter** informing them that Transitional Relief has been extended and they are able to renew into that policy for the upcoming year.

If a group scheduled to renew between April 1, 2017 and July 1, 2017 has already completed their 2017 renewal, they can change their plan selection to their 2013 Transitional Relief policy by following the standard "Renew with changes" process.

If your clients have not been mailed a 2017 renewal offer:

Oxford New Jersey small groups scheduled to renew their 2017 coverage on or after Aug. 1, 2017 will receive a renewal offer that includes the ability to renew into their 2013 Transitional Relief policy. A **cover letter** explaining the Transitional Relief extension will be included. These groups should follow the standard renewal process.

Online Transitional Relief renewal not currently available.

At this time, groups are not able to renew their 2013 Transitional Relief policy through our online renewal tool (IDEA). We expect that capability to be enabled in the coming months and will notify you when it is available.
