



New quote and enroll tool, expanded specialty portfolio for level-funded, small business plans in select states

Beginning April 1, Small Business brokers serving clients with 5–50 employees will be able to quote and enroll new UnitedHealthcare Level Funded plans in AL, DE, ND, SD, and Oxford Level Funded plans for small businesses in CT and NJ using SAMx – Level Funded, a new tool available on uhceservices.com.

SAMx – Level Funded will replace myallsavers.com for new, small business medical, dental, and vision quotes and enrollment needs

only. myallsavers.com will continue to be used to process renewals for existing business and to perform account maintenance on groups sold before Dec.

1. Quotes that have already been entered, or cases that have already been submitted, through myallsavers.com for May 1 effective dates *will not* need to be re-entered in SAMx – Level Funded.

SAMx – Level Funded will allow users to:

- Shop, quote and package UnitedHealthcare dental and vision products alongside medical plans
- Change a group's plan and/or add products to a plan
- Update enrollment to add or remove plan participants and dependents

Access to uhceservices.com

Brokers will need to have access to uhceservices.com in order to use SAMx – Level Funded. Any broker appointed to sell UnitedHealthcare Level Funded or Oxford Level Funded business in the applicable markets who does not currently have an active uhceservices.com account will receive an email on March 22 from notification@uhceservices.com that invites them to use the site and provides directions on how to activate their account.

Brokers must activate their account within 60 days of receiving the email. If the account is not activated within this time frame, they will need to contact the Broker Services team to request a new invitation.

Expanded specialty offerings

Dental and vision products will be available to quote alongside UnitedHealthcare Level Funded and Oxford Level Funded medical plans. Enhancements include:

- **Dental:** Increased product portfolio, more flexible plan availability, DHMO (where applicable) and dual-option capabilities
- **Vision:** New product portfolio with enhanced benefits, expanded contact lens benefit, second exam and retinal screenings for diabetics (5–100)
- **Consolidated billing:** Available when a new group purchases dental and/or vision products alongside UnitedHealthcare Level Funded or Oxford Level Funded medical products
- **Single point of contact:** One contact for medical and specialty products
- **Packaged Savings®:** Available to new Small Business (5–50) plan sponsors
