## ACTION REQUIRED: Enroll OHP New York HMO Groups in an OHI Plan by Jan. 31, 2017

As a reminder, New York small groups that currently only offer an Oxford Health Plans (NY), Inc. (OHP) HMO plan need to take action to purchase a new Oxford Health Insurance, Inc. (OHI) policy before their current OHP plan ends. These groups did not receive a renewal package from us and need to apply as a new group.

For your convenience, suggested OHI replacement options have been loaded to our online enrollment tool (IDEA). These options have similar cost shares and benefits to the current OHP HMO plans and are at the same metallic levels.

You can use IDEA to enroll groups in new coverage and upload required supporting documentation such as tax documents and waivers. Submitting the required documentation online will result in a faster completion turn-around-time compared to submitting manually. If you can't access our online tool, you can also send us a paper application.

Replacement information for Feb. 1, 2017 groups that currently only offer an OHP plan design will be available in IDEA through Jan. 31, 2017. After Jan. 31, 2017, information previously entered into IDEA for these groups will no longer be available and manual submission will be required in order to maintain existing group and member ID numbers.
