### July 1, 2016 PDLs for New York and New Jersey Clients, and Tristate Summary Flyers

The attached Prescription Drug Lists (PDLs) are effective on July 1, 2016 for Oxford plan members in New York and New Jersey with an Advantage or a Traditional prescription drug plan, as well as any new Oxford pharmacy benefit business in those states effective on or after July 1, 2016.

Flyers summarizing the July 1, 2016 updates are also included below for your reference. **The summary flyers reflect changes for New York, New Jersey and Connecticut Oxford plan members.**

PDLs for Oxford plan members in Connecticut with an Advantage or a Traditional prescription drug plan are not yet ready for release. We will send you an update when they are available.
