- For those who enrolled after the effective date or made roster changes after the billing cycle, your credit/debit will reflect on your February invoice.

Please remember:

- Large Groups, with 51+ employees- We are sending a spreadsheet of data that will provide employee and dependent coverage dates and demographics.
- Small Groups, with 50 or less employees- We are sending completed forms 1094-B and 1095-B.

Important Note Regarding Filing Deadlines

- Distribute 1095-B or 1095-C to Employees: March 2, 2018
- File on Paper with IRS: February 28, 2018
- File Electronically with IRS: April 2, 2018

* Taxpayers can prepare and file their returns using other information about their health coverage. They do not have to wait for Forms 1095-B or 1095-C to file.

NJ Opioid Reform effective January 1, 2018

The Plan covers NJ Opioid Reform effective January 1, 2018. Utilization Review-for the first 180 days per plan year, coverage of inpatient and outpatient treatment of substance use disorder shall be provided when

determined medically necessary by the covered person's physician, psychologist or psychiatrist without the imposition of any prior authorization or other prospective utilization management requirements. Coverage for the first 28 days of an inpatient stay during each plan year shall be provided without any retrospective review or concurrent review of medical necessity, and medical necessity shall be as determined by the covered person's physician. The benefits for days 29 and thereafter or inpatient care shall be subject to concurrent review. If you have any questions, please call Customer Service at 1-888-670-8135.
