What is the overall deductible?	<b>\$0</b> for OMNIA Tier 1 <u>providers.</u> <b>\$1,500.00</b> /Individual or <b>\$3,000.00</b> / Family for Tier 2 providers. Are there services covered before you meet your deductible?	Yes. <u>Preventive</u> care is covered before you meet your <u>deductible</u> . # Does this plan provide Minimum Essential Coverage? Yes
