Important Questions	Answers	Why This Matters:
What is the overall deductible ?	\$0 for OMNIA Tier 1 providers . \$1,500.00 /Individual or \$3,000.00 /Family for Tier 2 providers.	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible .
Are there services covered before you meet your deductible ?	Yes. Preventive care is covered before you meet your deductible .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible . Are there other deductibles for specific services?	No.	You don't have to meet deductibles for specific services.
What is the out-of-pocket limit for this plan ?	For Health/Pharmacy OMNIA Tier 1 providers \$3,000.00 Individual/ \$6,000.00 Family and for Tier 2 providers \$4,500.00 Individual/ \$9,000.00 Family. Aggregate family. OMNIA Tier 1 accumulates to Tier 2.	The out-of-pocket limit is the most you could pay in a year for covered services. If you have other family members in this plan , they have to meet their own out-of-pocket limits until the overall family out-of-pocket limit has been met.
What is not included in the out-of-pocket limit ?	Premiums , balance-billing charges and health care this plan doesn't cover.	Even though you pay these expenses, they don't count toward the out-of-pocket limit .
Will you pay less if you use a network provider ?	Yes. See www.HorizonBlue.com or call 1-800-355-BLUE (2583) for a list of in-network providers .	You pay the least if you use a provider in OMNIA Tier 1. You pay more if you use a provider in Tier 2. You will pay the most if you use an out-of-network provider , and you might receive a bill from a provider for the difference between the provider's charge and what your plan pays (balance billing). Be aware your network provider might use an out-of-network provider for some services (such as lab work). Check with your provider before you get services.

Do you need a **referral** to see a **specialist**? No. You can see the [specialist](#) you choose without a **referral**.
