What is the overall deductible?	Family for in-network <u>providers</u> and \$4,000.00 / Individual or \$8,000.00 / Family for out-of-network <u>providers</u> .	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. Are there services covered before you meet your deductible?	Yes. <u>Preventive</u> care is covered before you meet your <u>deductible</u> . Does this plan provide Minimum Essential Coverage? Yes
